### MINUTES

- 1. CALL TO ORDER: the meeting was called to order by President R.C. Brody at 6:10 p.m. A quorum was established with Directors Beth Burnam and Nancy Helsley in attendance. Directors Deborah Klein Lopez and Steve Rosentsweig were absent. Also in attendance was Executive Officer Clark Stevens.
- 2. INTRODUCTION OF GUESTS: there were no guests.
- 3. PUBLIC COMMENTS: there were no public comments.
- MINUTES: Approval of minutes for meeting of March 26, 2018. Approval tabled until next meeting due to lack of quorum.
- 5. MONTHLY CLAIMS AND FINANCIALS: Approval of Claims for March 2018 and review of financial reports through March 31, 2018. Directors discussed the new financial report format and made suggestions for format modifications. Moved/Seconded: Ms. Burnam/Ms. Helsley; approved 3-0.
- 6. REGULAR CALENDAR
  - A. Approval of new Strategic Plan for 2018-2021: Directors reviewed the document and noted that the dates were inconsistent. The Board directed that the dates be set for 2018 to 2022, then approved the RCD's new Strategic Plan. Moved/Seconded: Ms. Burnam/Mr. Brody; approved 3-0.
  - B. Review and possible approval of letter requesting change in Board appointment timing: the Board reviewed the letter and decided to table this item to the next meeting in order to clarify appointment years.
  - C. Approval of contract with National Fish and Wildlife Foundation in the amount of \$44,857.85 to continue replanting and maintenance of the lower Topanga Creek State Park restoration site: the Board reviewed the contract as well as the subcontract with TreePeople for partial services, then voted to approve the contract. Moved/Seconded: Ms. Burnam/Ms. Helsley; approved 3-0.



D. Approval of funding to support Granada Hills High School Envirothon Team at National Championships competition: Ms. Helsley reported on the state Envirothon competition, where Granada Hills High School won first place, Arlington High School was second and Pacific Palisades High School was third. She requested that the RCD pay the entry fee of \$1800 to help Granada Hills go to the national Envirothon competition in Pocatello, Idaho. Directors discussed the budget and noted that \$1000 has already been allocated, then voted to approve an extra \$800 to cover the entire registration fee. Moved/Seconded: Ms. Helsley/Ms. Burnam; approved 3-0.

- Ms. Burnam was invited to be a panelist at the Luskin Center last week on the discussion of a book about wildfires. She was joined on the panel by wildfire experts and the LA City Fire Chief.
